# Council Meeting Minutes Wednesday March 22, 2023 at 1900h Via Videoconference

## **Call to Order**

Richard Cranston called the Council Meeting of March 22, 2023 to order.

A quorum (17) of Council members were present.

#### Opening Prayer Rev. Heather

Rev. Heather presented and read aloud *A Covenant for Our Serving and Leading Together (March 2023)* in preparation for the opening prayer. This new Council covenant will be read aloud together at the next in person Council meeting and shared at the June congregational meeting.

#### **Opening Remarks** Richard Cranston

Richard welcomed Joan Cobbold, representing Trustees. Dana Bryant-Giguere expressed thanks for everyone's concern for Mike, who was recently hospitalized. Richard reviewed video conference courtesies and procedures, including voting by verbal response for opposition or abstention. There were no changes to the circulated agenda.

## Review & Approval of January 25, 2023 Council Meeting Minutes

The circulated minutes were revised as follows:

Page 3, first sentence corrected to read: Shawn Bausch will offer Victoria...news pieces.

- Page 3, Financial Reports, 2023 Budget, first bullet point below the motion corrected to read: \$44,810 in funding for Extra Ordinary Expenses is \$20K from the Reserve Fund set up in 2021, with the balance from other undesignated funds held in various other accounts.
- All instances of *TUCC* to be changed to *UCC* or *The UCC*.
- MOTION to Council by Al Hubbard that the Council minutes of January 25, 2023 be approved as amended. SECONDED by Steve Shaver. Motion CARRIED.

#### **Email voting Since Last Council Meeting**

## Amalgamation Committee Update Steve Shaver

- MOTION to Council by Steve Shaver to go in camera. SECONDED by Carol Wilson. Motion CARRIED.
- Steve Shaver gave a confidential overview of the rationale behind the decision of the Joint Amalgamation Committee (JAC), as reported in the letter to be sent to the congregation on March 23, to postpone amalgamation talks. After acknowledging the efforts of the Christ First team, he invited questions from Council.
- MOTION to Council by Steve Shaver to go out of in camera. SECONDED by Joan Cobbold. Motion CARRIED.
- There was consensus that Christ First should now move forward with important initiatives and
  exploration of our congregation's vision while amalgamation talks are paused. Carol Wilson will
  reconvene the congregational workshop planning group and report back to Council.
- Steve will send a courtesy note to all staff to provide advance notice about the congregational letter to go out from the JAC.

## **Business Arising from Previous Minutes**

## **Hub & Spoke Project**

• Rev. Heather has had detailed conversations with Richard Cranston, Rick Donaldson and Shawn Bausch in follow up to questions and concerns raised at the January Council meeting, with a view to ensuring questions are being addressed. While some answers are unfolding over time, Rev. Heather anticipates setting a date soon to gather all interested parties for in depth discussion. Steve Shaver requested that the Rural Connect Agreement be on the agenda for the meeting.

#### 2022 Roll Report

• Carol Wilson reported that there has been a correction by the Roll Clerk to the spelling of Ken Kinchen's name on the 2022 Roll Report approved by Council in January.

#### **Reports from Ministerial Team**

Victoria Keane – Youth & Family Ministry, Community Engagement Coordinator

Victoria highlighted the addition of a new family to worship and youth programs

Upcoming non-profit networking breakfast on April 24 will feature a guest speaker from Access 2
 Accessibility who would be a valuable resource as we consider the future of our buildings.

#### Rev. Heather Weaver-Orosz – Lead Minister

Rev. Heather led a discussion based on chapters 1-2 of *Five Practices of Fruitful Congregations*, with a focus on the crucial role of hospitality. There was general agreement that a 'hospitality audit' should be undertaken as a future step. Rev. Heather will assemble a small group from across the congregation. Next month's discussion will focus on chapter 3.

#### **Committee Reports**

No issues or discussions arose from the committee reports submitted by Community Outreach, Congregation Support, Welcoming & Fellowship and Worship.

#### **Communications** – Al Hubbard

• All highlighted the request for Annual Report submissions by May 21, with content to cover the 2022-23 year.

## Ministry & Personnel – Susan Gittings/Heather McGillis

• The motion contained in the M&P report is deferred pending further discussions with Finance about the aspects of the Treasurer's role that remain to be covered. If a bookkeeper is to be hired, there will still be an oversight role that must be provided by a Treasurer who is a church member, according to the UCC financial handbook. Clarke Grice has reached out to UCC for guidance in the event a volunteer is not identified. Meanwhile, he will work with Dana Bryant-Giguere to finalize the job description for the role.

## **Property** – David Wheeler

- David highlighted 2 areas of concern and the proposed projects that would require unbudgeted funds to remediate them: a) need for new projectors in the Clarkson Campus sanctuary to improve the visibility of screen content during worship, and b) need for repainting and carpeting of the Port Credit Campus sanctuary, to make it more presentable for concert rentals.
- MOTION to Council by David Wheeler to approve the expenditure of up to \$10K for the purchase
  of 2 laser projectors for the Clarkson Campus to be funded by funds on hand. The existing
  projector will be repurposed for use in our buildings. SECONDED by Elisabeth Evans. Motion
  CARRIED.
- MOTION to Council by David Wheeler to allow Property to obtain quotes not to exceed \$40K for repainting and carpeting of the sanctuary at Port Credit Campus, subject to approval by Council at the next meeting. SECONDED by Pat Skinner. Motion CARRIED.
- Concerns have been raised regarding the mix of pews and chairs in the Clarkson Campus sanctuary. Property may consider prioritizing this issue at a later date.

## Spiritual Development – Teresa Madeira

 Volunteers will be needed to assist with the Music Camp and Vacation Bible School. In particular, the Committee is seeking volunteers who are musically inclined from within and outside the congregation, to assist with the Music Camp. All those interested should contact Victoria Keane or Teresa.

#### Trustees - Joan Cobbold

Richard expressed thanks for the leadership of Rick Donaldson, who will be stepping down from
his role as Chair of Trustees in June. Joan will represent Rick at Council until June, when she will
take on the role of Chair of Trustees and Daphne Donaldson will take over Joan's current tole as
Chair of Special Gifts.

## Financial Reports - Clarke Grice

## **2023 Financial Update – February**

- Clarke reviewed the financial statements setting out the position of Christ First as of February 28, 2023. Favourable results are attributed to Identified Givings and rental income.
- MOTION to Council by Clarke Grice that the financial summary and balance sheet of Christ First as of February 28, 2023 which have been reviewed and approved by the Finance Committee be approved as presented: SECONDED by Heather McGillis. Motion CARRIED.

## **Finance Committee Report**

- Clarke has drafted revisions to the *Policy on Expenditure Control (October, 2021)* for approval by Council. Carol Wilson will circulate the draft document to Council, along with explanatory notes contained in Clarke's Finance report, as soon as possible for approval by email vote.
- A reminder that expense submissions must include the applicable budget line for each expense.

## **New Business**

#### Lawn Sale Fundraiser proposal

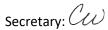
- Victoria Keane referred to the circulated proposal which details plans for this second annual event.
- MOTION to Council by Victoria Keane, SECONDED by Carol Wilson, to allow Victoria Keane and a team of volunteers to organize a Lawn Sale to be held outdoors on Saturday May 6, 2023 at the Clarkson Campus. The proceeds of the sale will be used to offset the general operating expenses of Christ First. Motion CARRIED.

#### **Spring Semi-annual Congregational Meeting**

- Meeting will be held on Sunday June 4 following a blended service
- Annual Report and Nominations Report to be presented for approval by congregation

## Recruiting Strategy and Meeting/Reporting Cycles for 2023-24

- In addition to the chair of Trustees, co-chairs of M&P have recently informed Richard and Carol of their plans to step down in June. Richard offered words of gratitude to Sue Gittings and Heather McGillis for their leadership.
- Council members were asked to inform Carol Wilson and Richard Cranston of their intentions for the coming year as soon as possible if they haven't already done so, and to begin polling



- committee members about their plans. Carol will collate the draft Nominations Report for presentation to the congregation.
- Rev. Heather, Rick Donaldson and Richard Cranston offered to form a working group to discuss recruiting for anticipated vacancies. It was suggested that additional group members be invited from the congregation.
- A change to bi-monthly Council meetings and committee reporting has been proposed to
  alleviate workload and time pressures for Council members. Business emerging between regular
  Council meetings can be handled via email vote (in the case of straightforward matters) or by the
  Executive Council as needed. There was general agreement to this proposal, with the change
  taking effect for the 2023-24 program year beginning in June.

#### **UCC Remit**

Richard has received the announcement of a Category 3 Remit from The UCC, regarding the
establishment of an Autonomous Indigenous Organization within The UCC. Congregations are
asked to vote by March 31, 2024. Richard will circulate the information package to Council
members for discussion regarding an action plan at a future Council meeting.

## **Correspondence**

• Richard Cranston has received a query from the Rev. Bob Johnstone on the status of Christ First's plan to explore the possibility of becoming an Affirming Community of Faith. The idea was first raised at the November 2019 Visioning Session and Council subsequently passed a motion giving direction to Future Planning Group to explore the requirements. Shortly thereafter, FPG initiatives were put on hold due to the pandemic. FPG would like to resume this exploration. Richard will gather information about the requirements for the process for distribution to FPG and Council, and provide an update to Bob.

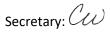
